

1. Make Sure Your Parent or Guardian is Registered:

State Requirements for Obtaining a Texas Driver's License

	Mail the completed form to the Texas Department of Public Safety with a check or money order for \$20 at: Texas DPS - License Issuance Bureau P.O. Box 149246 Austin, Texas 78714-9246
	The Parent-Taught Driver Education Packet from the Texas DPS will arrive within 2-3 weeks notifying you that your Parent/Guardian has been approved.
2.	Begin your I DRIVE SAFELY course Once you complete the first 6 hours of the course, you will receive a 6-Hour Permit Qualification Certificate (DE-964E) via email. Be sure to add wecare@idrivesafely.com to your address book or safe sender list so our emails get to your inbox. If you do not receive the email within 48 hours, contact Customer Support at 800-990-2814. At this point, you should wait to continue with the course until you complete Step 3 below.
3.	Go to your local DPS office to take your Texas Permit Exam and vision test, and receive you Learner's Permit! Bring the following to the DPS office to take your written permit exam: Your 6-Hour Permit Qualification Certificate (DE-964E) Proof of identity (such as a birth certificate) Social Security card Completed forms from the Parent-Taught Driver Education Packet: Application for TX driver's license (DL-14A) Parental Driver Education Affidavit (DL-90A) Verification of Enrollment and Attendance (VOE) form Classroom Instruction Record (DL-91A) for PTDE Proof of vehicle registration and insurance \$16 permit fee
	You have 3 opportunities within 90 days to successfully pass these tests.

4. Continue your Parent-Taught Driver's Ed course and start your instruction behind the wheel

You must continue with your I DRIVE SAFELY course for your permit to remain valid.

- Fill out the training logs provided in the DPS Parent-Taught Education Packet as you complete your behind-the-wheel training
 - The logs document the amount of time you spend in training

NOTE: You must complete 34 hours of documented behind-the-wheel training; 10 of those hours must be at night.

5. Complete your I DRIVE SAFELY course

Once you successfully complete the course, you will automatically receive your Certificate of Completion via the shipping option you chose.

6. Take your Driving Exam at the DPS

You must hold your learner's permit for a minimum of 6 months before you can take your driving exam and
get your driver's license. When you're ready, make sure to bring the following:

- ☐ Your learner's permit
- I DRIVE SAFELY Certificate of Completion
- ☐ Classroom and behind-the-wheel logs (DL-91A and DL-91B)
- ☐ Parental Driver Education Affidavit (DL-90A)
- ☐ Verification of Enrollment and Attendance (VOE)
- Proof of vehicle registration and insurance
- \$16 provisional license fee
